## **MEMBER UPDATE – FALL 2010**

## Disposition of the AVICC Resolutions from the April 2010 AVICC AGM & Convention

17 resolutions endorsed at the AVICC's 2010 AGM & Convention will be coming forward to the upcoming UBCM Convention for consideration during the regular resolutions sessions including the revised resolution on **Derelict & Abandoned Vessels, Barges and Docks** (see Resolution B30, pg 30 in the *UBCM Annual Report and Resolutions* book) which incorporated the salient points of RR1, R4, R5 and R6 sponsored by Sooke, North Saanich, Islands Trust and Sechelt respectively.

Two resolutions, LR 12 – Rail Terminus in Nanaimo and LR 13 – Coastal Douglas Fir Moist Maritime Land Use are regionally focussed and as a result have been disposed of by AVICC Executive. The letters are posted on the website. The responses will be posted when they have been received.

The LR2 - B.C. Ferries Fare Increases resolution asks UBCM to form a task force with the provincial government. The UBCM Resolutions Coordinator advises that this resolution will be forwarded directly to the UBCM Executive for action.

The City of Parksville chose to provide UBCM with a revised resolution replacing **LR11 – Physical Access for Disabled Passengers**. AVICC acted on the original resolution by forwarding a letter to Ministers Baird and Bond.

#### **Derelict Vessels Workshop at the UBCM Convention**

A further outcome of the discussions held by the Derelict Vessels Sub-Committee to draft the revised resolution was a proposal for a clinic or workshop to be scheduled at this fall's UBCM Convention. The proposal was accepted and has resulted in being one of four concurrent workshop sessions offered Thursday afternoon.

Finding Solutions to the Management of Derelict Vessels 2:00 - 4:00 pm Thursday, September 30, 2010 Fitzsimmons Room Whistler Conference Centre

The session will highlight local government concerns regarding derelict vessels; profile a successful approach to managing derelict vessels in Washington State; and examine the feasibility of enacting changes in legislation and policy to prevent and manage the proliferation of derelict vessels, barges and docks in British Columbia and Canada.

#### **Derelict Vessels Workshop at the UBCM Convention, Con't**

The workshop will open with experiences from a local government perspective, followed by a presentation from a representative of the Washington State Derelict Vessel Removal Program to overview their successes and challenges. A Transport Canada representative will then provide a brief summary of the current status of Canadian policy and legislation in this area and a representative from the BC Integrated Land Management Bureau will provide the provincial perspective. These presentations will be followed by a question and answer session.

Mayor Causton, AVICC President, will moderate the session. Presenters will include:

The following is an excerpt from an email received by Mayor Causton, President:

"I am Serge Vaillancourt a five-year post-liver transplant recipient. I became aware of the significant amount of blood required for my operations and the continuous demand for blood in order to save lives on a daily basis.

Canadian Blood Service's "Workplace Partner for Life Program" and "BC Transplant Society's Give Life at Work Program" do save lives. Some municipalities and major employers are participants in these programs. My goal is providing the contact information and urging those in receipt of this information to consider participating either individually or collectively.

Having staff contact these agencies on behalf of their residents in order to see what is involved could make participation become a reality and can only result in saving lives. I am requesting that you forward this information throughout your Association."

#### **Right To Know Week Proclamation**

The week of September 27 to October 1, 2010 is Right to Know Week across Canada. The purpose of Right To Know Week is to promote awareness of the rights of British Columbian citizens to access documents held by public bodies. Information and Privacy Commissioners across Canada and internationally will be holding events to celebrate the week.

We hope that the Association of Vancouver Island and Coastal Communities (the "Association") will take a lead role by proclaiming this important event. Our office has sent individual letters and draft proclamations to fifty municipalities in BC, but to spread the message further, we were hoping that you would be able to send an email attaching our template proclamation to your members for their consideration.

British Columbia's *Freedom of Information and Protection of Privacy Act* is described as being a pioneering piece of legislation. Right to Know Week offers an excellent opportunity for the member municipalities of the Association to emphasize this and to affirm the importance of the access rights of citizens.

I therefore write to ask that the various municipalities in your Association proclaim September 27 to October 1, 2010 as "Right To Know Week". A draft template of such a proclamation is enclosed.
