DELEGATION ON SOLID WASTE MANAGEMENT

First Vice-President Solda welcomed Chair Edwin Grieve, Vice-chair Jon Ambler and CAO Debra Oakman from the Comox Valley Regional District. The guests highlighted the challenges individual regional districts, especially small ones, are having managing solid waste including standards being set by others; diversion is good, but reduces tipping fees collected which reduces funds available for operations; new disposal sites are difficult to locate; transportation and disposal security issues; and lack of volume to be efficient and difficulty in achieving economy of scale.

A disconnect between the Province and regional districts was noted. Minister Polak's announcement at UBCM that the target of removing 70% organics from the waste stream by 2020 will create additional challenges. The need for AVICC regional districts and the Province to work together to develop a Vancouver Island long-term solution was identified. There was agreement that this is a high priority for local governments due to the high cost of services. Glen Brown noted the possibility that funding might be available for capacity building under the Gas Tax Strategic Priorities Fund.

On motion by Past President Stanhope, seconded by EA Representative Marcotte, That AVICC staff request the assistance of staff from Comox Valley Regional District to identify a steering committee and develop a process or plan to facilitate AVICC regional districts and the Province to work together to develop a collaborative long-term solution for solid waste on Vancouver Island was CARRIED

UBCM Convention Debrief

First Vice-President Solda and Director Moglove noted their attendance at the meeting arranged by NCLGA and AKBLG to discuss the resolution process. Further discussion by Executive on the resolutions process will follow later in the meeting. The chilled relationship with the Province was also noted. The creative facilitation of the Climate Change workshop to incorporate more audience participation was highlighted. The keynote speaker and banquet entertainment was exceptional. Banquet and pricing of hotel rooms in the blocks was noted an issue for some members. Resolution process went well. Better transportation from ferry to Whistler is needed. First Vice-President Solda, Director Moglove and staff will communicate feedback into the Executive and Staff debrief processes. Program planning for the 2015 AVICC Convention will incorporate audience participation strategies.

Update on Natural Gas Operating Agreement File

Second Vice-President Price welcomed Jerry Berry, FortisBC's Consultant on this file who joined the meeting via teleconference to provide an update. He confirmed that all 26 agreements have been signed with 22 already being delivered. They will be consolidated and forwarded to BCUC for approval. Local government is ahead of the Province in that legislation is being considered and the Order in Council dealing with the major industrials will not be considered by the Minister for at least another month. Paul Murray was in contact with the ADM and would report back to Past President Stanhope.
