

MINUTES OF A MEETING OF THE ASSOCIATION OF VANCOUVER ISLAND AND COASTAL COMMUNITIES EXECUTIVE HELD AT THE VANCOUVER ISLAND CONFERENCE CENTRE 101 GORDON ST, NANAIMO JANUARY 18, 2013

President Joe Stanhope called the meeting to order at 11:00 am. Second Vice President Solda joined the group at 11:09 am.

<u>Delegation - Bill Bourgeois, Healthy Forests-Healthy Communities Initiative</u>

President Stanhope welcomed Bill Bourgeois who provided a broad overview of the work that the Healthy Forests-Healthy Communities has undertaken, the strategic action plan that has been developed and the draft report due to be released in February in preparation for the upcoming election. A copy of the presentation notes and the proposed leadership actions by local government and communities is attached. Mr. Bourgeois responded to a number of questions/comments posed by members including:

- Concern regarding forest land being sold for development
- The issue of local governments having to buy back parklands
- A role for AVICC and local governments is to advocate for changes needed to the Private Managed Forest Land Act
- The certification process may be able to be used to manage community concerns
- Issues/priorities are not the same for all local governments; need a provincial vision and funding to help communities develop a local vision; timber companies would then need to work with local communities to achieve vision

President Stanhope thanked Mr. Bourgeois for his presentation and expressed appreciation for the work that has been undertaken.

2013 AGM & Convention Planning

The various session proposals and proposed topics were discussed and key priorities were identified. Executive supported the idea of incorporating working breakfasts both days to allow additional programming opportunities. Staff will forward a survey following the meeting for Executive to further prioritize the topics.

Sponsorship Policy

On motion by Director Steeves, seconded by EA Representative Marcotte,

- 1. That a written sponsorship policy be established.
- 2. The policy should explain the purpose of convention sponsorship is to enhance the exchange of information between local government representatives and other governments, agencies, corporations, associations, and organizations in our communities. And further that sponsorship arrangements are an important source of funding for AVICC Conventions and keep the cost of the conventions affordable for all local governments.
- 3. The policy should provide for the division of potential sponsors of AVICC Conventions into three categories. The first group would consist of other governments, government agencies and crown corporations. The second group would be associations and non-profit organizations. And the third grouping would consist of private for profit corporations.
- 4. The policy should provide for approval criteria for each category.
- 5. The approval criteria for the first category would be the definition of the category (governments, their agencies and crown corporations). If the organization fell into this group, approval would be automatic with staff simply reporting to the Executive.
- 6. Approval for organizations falling into the second and third category would remain the prerogative of the Executive as per present practice and the Executive would apply criteria including appropriateness of the group, the issues that may be involved, financial implications and so on.

7. The policy should also include a list of do's and don't's for sponsoring organizations that clarify their role at the convention and what is appropriate conduct.

5. POLICY ISSUES

<u>Delegation – Gord Schoberg and Carol Greaves, Fortis BC and Doug Holmes, City of Nanaimo re Gas</u>
<u>Operating Agreement Renewal Process Update</u>

President Stanhope welcomed Gord, Carol and Doug who provided an update and distributed the proposed timelines attached as an appendix to these minutes. Key points/comments included:

- Template agreement was given to municipal lawyer this week; issues raised are not expected to be significant; anticipate that template agreement can be finalized by February.
- Communications strategy will be important; avoid terms such as "harmonization" and "amalgamation."
- Agreement is predicated on required legislative changes being made in fall of 2013; will require local government advocacy to Ministry of Environment in spring, 2013.
- Issues with conflict of interest provisions aren't anticipated; not raised recently with introduction of operating fees in Revelstoke.
- Relative to local governments' willingness to accept the template operating agreement, the City
 of Nanaimo has taken the lead in working with Fortis BC to develop the template, but has
 involved other local governments in the process. The legal review has been completed and paid
 for by the City of Nanaimo as it would have been difficult administratively to obtain the necessary
 approvals to split the costs.
- Although the template agreement will include provision for collecting operating fees, the decision will be made locally on whether to implement the fees. If operating fees are implemented, the first payout would be March 1, 2015 and each year thereafter. Carol Greaves can provide estimates upon request.

On a motion by EA Representative Marcotte, seconded by Director Moglove,
That the delegation be received and that if the template agreement has been finalized and Executive
is being asked to support and encourage members to sign the agreement during the 2013
Convention presentation that representatives be asked to provide an update to the April 11 Executive
meeting was
