5. POLICY ISSUES

Delegation – Graham Knox, Manager, Environmental Emergencies, Ministry of Environment
President Stanhope welcomed Graham Knox at 1:00 pm. A number of key issues were discussed including spill recovery, planning for handling of tsunami debris and the lack of progress in resolving the derelict vessel problem. The discussion noted the following key points:

- Funding for management and handling of tsunami and marine debris was identified as an issue that needs attention.
- Although there is no funding for local government to attend spills in other jurisdictions to observe and learn, invitations to participate are extended whenever possible.
- The issue of whether there is compensation available for aftermath/impact of spills (i.e. loss of the use of a beach/loss of tourism) once immediate cleanup has been completed was identified with response noting that there is a claim process, but there are limits of liability.
- There may be benefit for Graham Knox to participate on the Joint Working Group for Removal of Derelict Vessels.

Discussion of some key issues followed. The discussion noted the following key points:

• In terms of barriers, the commitment to low tax and regulation with new Net Zero policy on new regulation was identified. Executive noted the significant issue of ferry costs and service levels Minutes of the June 20, 2012 Meeting of the AVICC Executive

- not only in relation to tourism, but the competitive issue of the costs for businesses to get goods on/off the island and the impact on ability to attract employees.
- The importance that the strategies and initiatives being undertaken by the Province consider the needs of small communities, employers and businesses was identified.
- The fall Trade and Investment Representative Road Show will include Campbell River in October;
 Director Solda noted that Port Alberni would like to be included as they would like to market their Port capacity.
