

MINUTES OF A MEETING OF THE ASSOCIATION OF VANCOUVER ISLAND AND COASTAL COMMUNITIES EXECUTIVE HELD VIA TELECONFERENCE MONDAY, MAY 14, 2012

President Stanhope called the meeting to order at 9:05 a.m. The agenda was adopted by consensus.

MEMBERS IDENTIFICATION OF KEY PRIORITY ISSUES

Members identified their key priority issues:

Director Palmer: Oil spill preparedness; federal/provincial regional plans for aquaculture

EA Rep Marcotte: Farming issues; electoral area boundary extensions

1st Vice President Cross: Oil spill and tsunami debris preparedness; aquaculture follow-up

2nd Vice President Solda: Oil spill and tsunami debris preparedness; job strategies; second highway Director Steeves: Marine issues (oil spill and tsunami debris preparedness and derelict

vessels)

Director Brame: Transportation (bus, E&N, Malahat closures); island-wide tourism strategy

President Stanhope: Derelict vessels; aquaculture; ferries

Discussion on the ferries issue led to agreement that next April's Convention would be an excellent timing point for Commissioner Macatee to address delegates on the issue; however, the May provincial election may impact his ability to present depending on whether the position is considered to be independent of government; the alternative would be to invite him come to the January Executive meeting.

JUNE MEETING AGENDA PLANNING

Based on the priorities identified above, Tsunami Debris Planning, Oil Spill Preparedness and Aquaculture Planning would be added.

Interests for delegations to be invited to the June meeting were:

- Invitation to Greg Goodwin, Jobs, Tourism and Innovation to gain more details about the jobs strategies being undertaken for the island and coastal communities.
- Invitation to staff in the Ministry of Forests, Lands and Natural Resource Operations to discuss issues related to water shed planning in relation to lands managed by private forest land managers like Island Timberlands and availability of provincial funding currently available.
- Follow-up to the Oil Spill Preparedness session to obtain more details about the strategies and planning.
