4. POLICY

a) BC Ferries – Special Committee on BC Ferries

President Cross provided an update on the work of the Special Committee on BC Ferries, acknowledged that there has been no resolutions submitted by the membership by the February 24th deadline that includes the topic of BC Ferries.

Executive discussed the panel session on BC Ferries planned for Friday, April 11th at the Convention. Staff was directed to circulate a list of proposed panellists to the Executive for their consideration. Executive discussed the possibility of submitting a late resolution requesting the provincial government undertake and fund a full socio-economic study on the impact of reduced ferry schedules and rate increases on coastal communities. Staff will work with UBCM to draft and submit to Executive a proposed late resolution to be considered at the April 10th Executive meeting.

On a motion by First Vice President Solda, seconded by Past President Stanhope That staff will forward a copy of the Report by the Special Committee on BC Ferries to Executive for their consideration once finalized, as well as draft a request for endorsement from the AVICC Executive to the membership, and That staff will work with UBCM staff to draft a late resolution requesting the province undertake a full socio-economic impact assessment of the announced service cuts and rate increases on coastal communities for their consideration at the April 10th Executive Meeting, and

That staff will electronically circulate a list of proposed panelists to the AVICC Executive for their consideration and feedback was

b) Vancouver Island Rail Line

First Vice President Solda noted that reopening of the Vancouver island passenger rail service is not looking very promising, very concerned about losing the major linkage of the rail line on the island. Vice President Solda indicated that a late resolution could be introduced at the AVICC that would reaffirm the need for the passenger rail service on Vancouver Island.
