Comox Valley CAO, Debra Oakman reported that the Comox Strathcona Waste Management Board had approved \$25,000 in funding for the initial research project which will be reported under the following agenda item, and that as identified in the prior report, the Comox Valley Regional District would be contributing staff time to support the Committee. The Regional District of Nanaimo's contribution of meeting space was also noted. To be able to get a sense of the true costs of the project, all of the regional districts were requested to track the time/costs including hourly rate plus benefit addition for their in-kind contributions to this Committee.

COMOX VALLEY REGIONAL DISTRICT RESEARCH
