KEYNOTE SPEAKER: TOMSON HIGHWAY



Tomson Highway was born in a snowbank on an island in the sub-Arctic, the eleventh of twelve children in a nomadic, caribou-hunting Cree family. When Tomson was six, he was flown south by float plane to attend a residential school. He lived through the residential school system, faced prejudice, and struggled to have his work recognized. Along the way, he relied on music and art to heal and inspire himself and others around him.

He’s an acclaimed artist making an international impact as a playwright, author, musician, and multilingual speaker (Cree, French and English).

Highway has also found time to work as a social worker, Native artistic director, adjunct professor, and world traveller. For years he immersed himself in the field of Native social work, working on reserves and in urban centres across Canada. He then decided it was time to put all his artistic training and his Native social work experience together – he started writing music, plays, and later, novels.

He achieved international recognition with his multi-award-winning plays *The Rez Sisters* and *Dry Lips Oughta Move to Kapuskasing*, which was the first Canadian play to receive a full production and extended run at Toronto’s legendary Royal Alexandra Theatre. His artistic groundwork gave birth to a nation-wide Native literary movement that continues across the country to this day. He’s been Writer-in-Residence at many universities and is the author of many bestselling books, including *Permanent Astonishment: Growing Up in the Land of Snow and Sky*, for which he won the Writers’ Trust Award for Non-Fiction. Several film and television documentaries on both his work and his background have been produced for the international market over the years.

A member of the Order of Canada and the recipient of at least 10 honorary doctorates, Highway has shaped the development of Aboriginal theatre in both Canada and around the world.

Study Tour: 'Nanaimo Community Amenity Tour'

The City of Nanaimo has put together a guided bus tour that will give delegates the opportunity to visit five sites the City has developed to benefit the community. The tour will visit:



Five Acre Farm

A partnership with local non-profit Nanaimo Foodshare to continue providing community food and farming education programs at the last remaining, historic Five Acre Farm site in Harewood.



Harewood Centennial Park

Harewood Centennial Park – An inner-city park revitalized to become a community gathering place for all ages through enhanced amenities, including a kids' water park, covered sports court, improved pathways, accessible playground, a skateboard park and two artificial turf fields to be built in 2023.



Te'tuxwtun

Te'tuxwtun – A vision that integrates affordable housing, parks and culture, education, childcare and health services, Te'tuxwtun is the result of collaboration between the City of Nanaimo, Snuneymuxw First Nation, Nanaimo Ladysmith Public Schools and BC Housing.

Nanaimo Stadium District

Next door to Vancouver Island University and NDSS high school, this prime location for Nanaimo's key sports facilities includes an aquatic centre, ice rink, baseball stadium, track and field complex, multi-use trails and the Q'unq'inuqstuxw Stadium (named at the 2022 Truth and Reconciliation Day).



Steve Smith Bike Park

Built in 2017 to honour the memory of beloved local mountain bike champion Steve Smith. The bike park is host to top international competitions and is enjoyed by bike enthusiasts of all ages and abilities in the community. The area also include a skills development area and a BMX Track that will be improved in 2023.

FRIDAY PRE-CONVENTION PROGRAM

Study Tour: 'Greater Nanaimo Pollution Control Centre Tour'

9:00-11:30, Friday, April 14, 2023

Cost: \$40



The Greater Nanaimo Pollution Control Centre (GNPCC) is the largest of four wastewater treatment facilities owned and operated by the RDN and currently serves 100,000 residents and businesses in the City of Nanaimo, District of Lantzville and on Snuneymuxw First Nation land. The facility also treats septage from residential onsite septic systems and wastewater from pump-and-haul properties.

The GNPCC Secondary Treatment Upgrade Project was completed in the spring of 2021. With over 10 billion litres of wastewater treated annually, the facility upgrade was needed to increase capacity for our growing communities and to achieve a number of objectives under the RDN's Liquid Waste Management Plan. Primary treatment (settling tanks and gravity) and secondary treatment (beneficial micro-organisms to consume organic matter) together remove more than 90 per cent of the solids from the wastewater before treated effluent is discharged to the ocean. Regionally, over 99 per cent of the wastewater treated by the RDN receives secondary treatment. The \$82 million upgrade is the largest capital expenditure in the RDN's history. A \$6 million federal Gas Tax Fund grant helped fund the project.

The GNPCC is in north Nanaimo. It is a neighbour to parks, a creek, an elementary school, community trails and a residential area. Join us on this tour to see the innovative features firsthand and learn more about the positive impact the facility has on the region and the environment. For example:

- Blast rock from the site was used to create stone columns that will stabilize the soils in the event of an earthquake.
- Odours captured around the plant are removed by the new biofilter and carbon filters, improving air quality for neighbouring residents.
- Solids that are extracted during the treatment process are treated further and used to enrich forest soils and reclaim industrial sites. These biosolids meet the quality criteria outlined in the Organic Matter Recycling Regulation.
- Biogas produced during the extraction process is used to heat the plant.
- A heat exchanger on the wastewater outfall heats a local elementary school.
- It operates under an ISO 14001 Environmental Management System.
- Follows an asset management program.

Legislative Reform Initiative: Building the Case

Cost Included in member registration

In June 2021, the Regional District of Nanaimo, with Don Lidstone, Q.C., hosted a session with regional district Chairs and CAOs to explore the possibility of mobilizing a collaborative effort to modernize the Local Government Act. Subsequently, at the April 2022 AVICC convention, the RDN and Alberni-Clayoquot Regional District (ACRD) hosted a workshop to continue the conversation and confirm support for this important initiative, hear from local governments about aspects of the legislation in need of reform, and focus forward momentum and interjurisdictional collaboration. An RDN resolution, endorsed at the September 2022 UBCM Convention, proposed that UBCM work with the Ministry and local governments to further this initiative. In September 2022, the RDN and ACRD met with the Minister of Municipal Affairs and a subsequent meeting to discuss specifics is anticipated.

Concerns with this dated legislation include restrictions on taxation and revenue sources, complexities in establishing services, and the lack of provisions in comparison with Section 8 of the Community Charter which gives municipalities powers to regulate, prohibit, and impose requirements by bylaw without provincial approval or establishing bylaws. Regional districts are limited in their legislative authority in comparison with municipalities in several key areas such as business licensing authority, subdivision approval, regulation of fireworks discharge, parking enforcement, tree management, and taxation and funding models. Further, social, political and economic environments that local governments operate within continue to evolve in areas such as climate change, environmental stewardship and a recognition of the importance of First Nations' participation in regional governance. These realities should be reflected in a modernized legislative framework.

This interactive, discussion-based session will build on the momentum and ideas from last year's AVICC workshop. The goal will be to gather from attendees specific examples of areas that need refreshing and modernizing, to build the narrative. The session will be of interest to municipal officials as well as regional district officials, since many aspects of municipal operations are contained in the Local Government Act.

RESOLUTIONS PROCESS

UBCM urges members to submit resolutions first to Area Associations for consideration. Resolutions received prior to the **February 9, 2023** deadline will be processed and included in the *Annual Report and Resolutions Book* that will be emailed to members in late March.

Resolutions received after the deadline are considered to be “**Late Resolutions**” and will be accepted by the Secretary-Treasurer up until noon, **Wednesday, April 12, 2023**.

Members are reminded that, to be admitted for debate, a late resolution must be deemed to be of an urgent or emergency nature and should address an issue that has arisen after the February 9th deadline date.

The Resolutions Committee will review all late resolutions and prepare a report for the Convention including a recommendation as to whether the resolution meets the criteria and should be admitted for debate.

Members can also propose a resolution from the floor of the Convention on Sunday, April 16, and members will vote on whether to admit the resolution for debate. See the convention rules around resolutions in the *Annual Report and Resolutions Book* that has guidelines for distributing printed materials to delegates for off-the-floor resolutions.

By registering, delegates are acknowledging that they are aware that they are expected to adhere to the 2023 Code of Conduct.

ASSOCIATION OF VANCOUVER ISLAND AND COASTAL COMMUNITIES CONVENTION CODE OF CONDUCT

2023 Convention

The AVICC Executive has implemented a code of conduct for convention participants based on the following principles.

1. The primary purpose of the annual AVICC Convention is to provide the membership with an opportunity to set the Association's policy direction for the year ahead.
2. The Convention also provides delegates with an opportunity to learn, share and meet with other local, provincial and federal government officials in addition to other associations that are interested in engaging with local governments.
3. All delegates and convention participants have the right to a safe, fun and enjoyable experience. AVICC will not tolerate any communication or behaviour that demeans, threatens, or harasses anyone at its events.
4. All participants at the Convention, regardless of their employer, their position, their perspectives or priorities will treat others, and be treated, in a respectful, understanding and cooperative manner and behave in a manner that is respectful to other participants and their guests, and will not do anything that threatens the health, safety, security, or dignity of other participants or their guests.
5. Only local elected officials who are AVICC members are entitled to speak and vote on matters put forward to the membership. However, the annual Convention is open to the public, and anyone may attend the Convention so long as they register.
6. All AVICC members are viewed as equal regardless of their population, location, or their ability to attend the annual convention.
7. Participants are expected to adhere to this Code of Conduct at AVICC and other non-AVICC organized events associated with the Convention; and will be required to sign a confirmation that they have read, understood, and agree to this Code of Conduct at time of registration.
8. Breaches of the code of conduct will be addressed by the AVICC Executive.
