



Executive Summary

- The BC Utilities Commission imposed an Interim Operating Agreement on AVICC municipalities in 1991.
- For most, this 1991 agreement has expired.
- Municipal and Fortis BC Operational Staff developed a new model agreement.
- Model agreement was reviewed by Stewart McDannold Stuart (on behalf of and paid for by the City of Nanaimo).
- This agreement is ready for distribution.



How Long Did It Take?

- July 2010 LGMA hosted a meeting with AVICC municipalities and Fortis BC to introduce the issues.
- Sep 2011 Joint Strategy Determined
- January 2011 Municipal operational staff determined priorities for a new agreement.
 - A smaller working group was formed.
- November 2011to July 2012 Fortis and the Operating Group met monthly to negotiate a "Made in Vancouver Island" agreement.
- March & October 2013 Final meetings of the Operating Group to endorse the agreement.

Key Components of the Model Agreement

- Preserves many of the municipal rights from the existing 1991 Operating Agreement.
- Streamlines the permit process for both Fortis BC and AVICC municipalities.
- Allows municipalities to maintain their own standards and specifications.
- Allows for an audit process ensuring proper repair of municipal services.
- More commitment towards cooperation, joint planning and coordination of work.



Permit Process



- New work (gas main extensions), requires drawings and 10-25 days to process permit.
- Impact service work (pavement, utility, trees, archaeological or environmental), requires a sketch and 5-10 days to process permit.
- Other service work (non impact), allows 5 days for municipalities to object to the work.
- Schedule "A" provides permit application form.



Operating Fees

- Model Agreement is conditional on municipalities being able to collect fees.
- Each municipality can determine whether or not to collect fees and how to spend it.
- Operating fees compensate municipalities for:
 - Permit, inspection and related costs including staff
 - Reduced municipal infrastructure service life
 - Gas relocation costs related to municipal projects
 - Emergency response to gas hits
 - Supply of drawings and information
 - Other costs related to gas installations



What Else Was Accomplished?

- Both parties gained a better understanding of each other's business requirements.
- Rebuilt the relationship between Fortis BC and AVICC municipalities.
- Completed the first step to allow AVICC municipalities to collect Operating Fees.



In Summary

- Our objective was to allow local government self determination but to negotiate as a group.
- Fortis BC and the Operating Working Group have created a model operating agreement reflecting this.
