- Transportation –

  - not being isolated
  - being able to bring people into your community
  - have modes of transportation that appeal to the people who will be your work force
  
- Tourism destination marketing
  - strategy planning → follow through on plans which sit on shelves
  - short-term residential use can benefit communities that have no hotels
  - identify your assets and enable people to invest in opportunities to create businesses
  - council needs to prioritize its projects so you don't overburden/burden staff.
  - look @ seniors retirement housing in rural areas
  - do more public engagement on economic development topics: find the voice of the community on how they want their community to evolve
  - use of incentive tax programs?
