Re: BC Ferries Service Levels

As President of the Association of Vancouver Island and Coastal Communities, I am writing to congratulate you for working with BC Ferries to ensure the proposed reductions in "above contract" sailings on eleven routes were avoided. You may remember from our previous correspondence that AVICC members are elected officials who represent 53 local governments on Vancouver Island, the Sunshine Coast, Powell River (qathet), the Central Coast and the North Coast.

As island and coastal residents, our members and the communities they serve rely on BC Ferries. We agree whole heartedly with your statement that: *"it's very unfortunate and premature to be making these cuts when we are all working on rebuilding our economy and our communities," Trevena said. "I know that this is going to have a huge impact on the people living and working in coastal communities."*

The AVICC Executive has had a request from one of our members to re-establish the 2014 AVICC & UBCM Special Committee on BC Ferries. The Comox Valley Regional District would like the committee to undertake further work on the socioeconomic impacts of BC Ferries in consideration of planned service reductions, and to support the development of a sustainable coastal ferry system. The AVICC Executive understands the proposed cuts were temporary service reductions rather than the permanent reductions planned when the 2014 Special Committee was established. Given that the temporary service reductions are being avoided with the support of your Ministry, the Executive decided it would be premature to reactivate the special committee at this point, but if there were indications these might be permanent we may revisit this decision.
