### Bottom Line Impact



#### **Rate Stability**

Since 2017, the MIABC has capped premium increases at 10% for members whose liability premiums rise more than 10% from the previous year, due to underwriting considerations such as claims experience.



#### **Risk Management Grants**

The MIABC annually returns 1% of its equity to members to help fund proactive risk management initiatives. In 2023, MIABC disbursed over \$525,000 in grants to support these endeavors.



#### **Risk Management Conference**

The MIABC hosts an annual Risk Management Conference for local governments. Members benefit from subsidized registration fees and can utilize grant funds for conference expenses, reducing the economic barrier of attendance.

#### **Scholarship Program**

To enhance risk and insurance expertise in local government, MIABC members can apply for funding to cover tuition and textbook costs for the Canadian Risk Management or Chartered Insurance Professional designation.
